### **Fire Department**

March there were 9 runs, 4 medical, 2 PI/PDAs, 1 barn-fire, 1 car fire, 1 false alarm, YTD 49. Each new firefighter's record will be checked prior to being accepted as a firefighter.

All current firefighters driving records are clear.

### **Planning Commission**

Commission is reviewing Section 5.08 as per Township Attorney; Commission would like to confer with Attorney on Section 16.06, former agriculture buildings.

Motion by Dijak/Begick to reappoint Dave Marr, Dave Helmreich for 3 year term and Ronald Campbell for a one year term on the Planning Commission. Carried.

### **Old Business**

#### **Euclid & Stone Island Water Line**

Motion by Appold/Begick to adopt the agreement prepared by Township Attorney for the new, Euclid Stone Island water line. Roll call vote; Dijak yes, Revord yes, Campbell yes, Begick yes, Appold yes. No none. Carried.

Motion by Appold / Revord to adopt the ordinance number\_\_\_ subject to correct legal description as in the agreement and the commodity charges be listed at the current rates that are being charged. Roll call vote, Dijak yes, Revord yes, Campbell yes, Begick yes, Appold yes. No none. Carried.

#### **Road Patrol Contract**

The contract was not signed because of the higher cost. After discussion, this was tabled until further discussion with other Townships involved.

### **New Business**

#### **Lawn Mowing**

Bids were received from Site Service, Beaver Trucking, Arthur Lawn Care, 4 Seasons Landscaping, Surf Works, Bob's Lawn Care, Great Lakes Hydro Seeding and Landscaping, Inc., O'Donalds, Reder Landscaping, and Ground Control Landscaping Motion by Revord/Appold to hire Arthur Lawn Care for a three year contract. Carried.

#### **Road Mowing**

Leon Leszczyński will do the road mowing again this year, for \$47.00 per mile.

#### **Sewer Assessment**

A lot has been purchased on Amelith Road. Buyer would like to buy into the sewer and catch up with original sewer assessment. After discussion, it was decided to abide by the ordinance requiring buyer to pay the minimum 10% and the balance in 18 years, as per the ordinance.

#### **Ditching Funds**

Vern Engelhardt, 6881 Three Mile Road, would like the County to clean out ditch from Freeland Road to Engelhardt Road. Cost would be \$4,730. Mr. Engelhardt would pay half of the cost.

Motion by Appold/Dijak to hire the County to do this project. Township will pay \$2,365 and Mr. Engelhardt will pay \$2,365. Carried.

#### **Roads**

Road improvement tabled at this time.

Motion by Dijak/Begick to pay bills of \$39,866.35.
