I recently had a conversation with the M.D.O.T. engineer in charge of the M-84 project. They anticipate having our section of M-84 done sometime in late Fall, as long as unforeseen issues do not hinder the work. Most of the infrastructure (water and sewer lines) has been moved, which should help make the next phase less time consuming,

You recently received a hearing notice with no explanation - I apologize for this mishap. Our contract with Waste Management expires December 31, 2010, for curbside trash pick-up. In order to accept a new contract, we must, by law, follow a procedure which requires many steps. The first hearing notice establishes the assessment district (who will receive trash pick-up and be assessed). You will receive a second hearing notice which establishes the assessment roll (the cost for trash pick-up). This notice should be in your mail by September 17th-20th. If you have any questions, please call. We will try to explain this in layman terms.

We are continuing to monitor the local roads that are most affected by the M-84 project. I have asked the Bay County Road Commission for preliminary estimates as to the cost to maintain or repair these roads, which will begin in 2011, pending the M-84 project completion in our Township.

Once again we ask that you continue to support our local businesses as the M-84 project nears completion.

November 2, 2010 is the General Election. The last day to register is October 4th. By Michigan Election Law, voters that voted as an Absentee Voter for the Primary will receive their ballot for the General Election. Voters that have not applied and would like to vote need to sign an application available at the Township Office.

A synopsis of May, June, and July Township Board Meetings follows:

May 11th: The Michigan Electric Transmission Co., a subsidiary of ITC has purchased the Transmission Lines crossing our Township on Three Mile. The Board was given advance notice that METC will soon begin replacing the existing structures and wires starting May to November, 2010. If you have concerns, their e-mail address is bmention@itctransco.com. ~ Motion to accept a proposal to purchase a Breathing Air System to refill their air supply tanks. ~ A progress inspection by three firefighters was made on the new fire truck being built in Iowa. ~ 150 tons of seal blend has been purchased at a cost of \$7500.00 to repair various roads to maintain a prior chip & seal road; a motion was passed to apply the required third seal.

June 8th: State Representative Dennis Poirier, from the 96th District, and Vaughn Begick, County Commissioner from 3rd District, were in attendance. ~ Motion to accept a three year Service Plan offered by David Chapmen Agency

I was very busy this last week with the collection of summer taxes. Any taxes paid beginning Sept. 15th should include a 1% interest per month until the middle of February 2011.

Your new pumper truck has arrived!! We received it in June, and after a few bugs were worked out, it is in service protecting the Township and its residents! Remember it is a pumper/rescue truck, so it has fire fighting capabilities as well as medical capabilities. It carries water, and also has backboards and the jaws-of-life so it can do multiple tasks. This vehicle has become our main truck to any call outside of a medical call. We have half of our staff trained on driving the pumper as of this article and will have the rest trained by the end of September.

We also have a new Firefighter to introduce: John Wieck, the son of current firefighter Dennis Wieck, has decided to join our department. John was a leading member of our Explorer group and after graduation decided to become a full member. Please take the time to join us in congratulating John on joining. We are very happy to see him become a member.

Speaking of the Explorer group, if anyone has children ages 14 years to 18 years and they are interested in the fire service, they are welcome to join our group. We have the only Explorer group to my knowledge in the county that pertains to the fire service. They will learn about the fire service and train with us. It is sponsored through the Boy Scouts and they are fully insured through them. Please remember to call in for a burning permit when you are doing that fall yard work! Remember that you can burn twigs and leaves, but no building materials or grass. Please be patient with us if you do call in for a permit and we still come out to your location. If someone calls in to 911, we have to respond. We will stop, make sure you called in a permit, check to make sure all the requirements are met to burn (proper materials, water supply, properly manned), and then we will clear.
