A sure sign of spring is the orange barrels popping up. This is a list of roads that will be worked on this year in our Township: Kloha Road west to Dead End - Chip and Seal; Frankenlust Road - Maintenance Seal; Delta Road - Maintenance Seal; Zeigler Road M-84 to bridge - Asphalt; Zeigler Road bridge to 2 Mile Road - Maintenance Seal; Amelith Road - replace culvert west of Fraser Road. Last month during all the rain and flooding, we had an issue at Delta and Fraser Roads as water was washing away the bank on Delta Road and was inches from collapsing the road. I would like to thank Cory Wale, Bay County Road Commission, for their quick action in resolving this issue. Although it cost the Township \$7,500, it would have cost the Township far more if the road needed to be repaired. As for the cost of roads to be worked on this year, the estimates are just under \$200,000.

If you pay by mail or drop box and would like a receipt, you must enclose a **stamped, self-addressed envelope**.

Have you sold your home or property this year? Please be sure to check with the new owner to see if they received the tax bill, or if you received it, be sure they get a copy. If you are a new owner and are not sure if the taxes have been paid, please kindly call the office to check with us.

If you are looking for a nice outdoor spot to picnic, don't forget our Township Park which has benches, picnic tables, a playground, and a small pavilion. There is also an outside bathroom during the summer months. I know with the prices of gas, we will have to have more picnics closer to home.

On March 8th, Alvin Appold resigned as Township Clerk. My name is Donna Reichard, and on March 24th I was appointed Township Clerk to fill the vacancy through November 20, 2012. I have been Deputy Clerk for AI for the past ten years and have been an election inspector for many years. Therefore I am very familiar with the Qualified Voter Files, Payroll, and the Accounting. If you get by the Hall, please stop in and say "Hi".

These are some of the happenings in the Township.

- The school elections will now be in November. At the present time, the only election we will have this year is the annual school election on November 8th. 
- Weed Ordinance 4A was adopted in February.
- Some scheduled road work for this year is Kloha Road (first year only), Frankenlust Road, Delta Road (Mackinaw to 7 Mile), Ziegler to 2 Mile, Ziegler bridge to 2 Mile.
- Jim Begick was appointed to the Planning Commission for a 1 year term beginning January 1, 2011.
- Mary Revord and Norbert Begick were appointed to the Zoning Board of Appeals for 1 year terms beginning Jan. 1, 2011.
- Jim Begick was appointed as Weed Commissioner.
- A bid was accepted from Leon Leszczynski to again do the road cutting for the Township. 
- Money was donated to St. Paul Lutheran and St. John Lutheran Schools for sports equipment with the intent that any Township children be allowed to participate in their programs.

We will be initiating a five year revaluation program during 2011. This is in adherence to the State of Michigan mandate for uniform assessments. I will be making on-site visits for 20% of the parcels each year. I'll be comparing the information that is currently listed as being on each parcel with what I observe. New additions will be added to the assessment roll for the 2012 Tax Year, while anything that has been removed will be deducted from next year's roll.



Be aware that your taxable value is not increased for repairing or replacing items that already exist on your property. Let's say your home is 35 years old and you have recently replaced windows, siding, soffits, or remodeled your kitchen or bath. As long as you have replaced or remodeled what you already have, your taxable value need not be increased. There is a State Tax Commission form, 865, titled, "Request for nonconsideration of true cash value of normal repair, replacement and maintenance expenditures". Completion of this form is not mandatory, but it does afford you the protection from unnecessary increases in taxable value. The form, along with instructions, is available at the Township Office. I'll be happy to answer any questions you have about its completion.

The first year I'll be updating agricultural parcels. I'll be updating soil types, tile, outbuildings, and structures, along with residential buildings and land improvements. If no one is home, I may leave a form letter for you to complete and return, or request a time when it is convenient for you to meet with me.

Want to Rent Out Your House or a Room in Your House?

If you own a residential home in Frankenlust Township, only one domestic family (and not more than one additional unrelated person) may live in each residence. Article 3.00 of the Zoning Ordinance defines "Dwelling, Single Family" and "Family" for a more detailed explanation of these terms. You can find our Zoning Ordinances at the Township Office, or



online at www.frankenlust.com. So, what if you want to rent your house out to multiple unrelated persons (e.g. college students)? This is not allowed. But, you can rent out your house to a single domestic family (assuming you are not also living at the residence). Owners who are living in their home do have the opportunity to apply for a Special Use Permit through the Planning Commission for the ability to have an Accessory Apartment. The accessory apartment can be used by a maximum of 2 persons, including singles, couples, married children, or other relatives. The 1-room accessory apartment must be a clearly isolated and subordinate part within a single family dwelling (garage space may not be connected); provide basic living, cooking, and sanitary facilities; and have 1 parking space. For more information, please review Article 3.00's definition of "Dwelling, Accessory" and the accessory apartment regulations set forth in Section 16.05 of our Ordinances.

Looks like spring is finally here! Remember that if you are cleaning up your yard from the winter storms and you plan on burning, you need to call in and register a burn permit with the Township Office. We need your name, address, and dates you will be burning.

We have responded to 123 calls so far this year and everything is going well. Your two new firefighters are done with training; they are just waiting to take their written and practical exams. When they pass (and they will all pass!) on the 21st of May, they will be fully certified to perform the duties required of all the firefighters.



The Explorers program is going very well. We have four Explorers so far, and we are pleased with their dedication and willingness to learn and to help. Remember, if anyone 14-18 years old is interested in the fire service, they are welcome to come down to the station on the 1st Thursday of any month and check us out. They will be able to train with us, go on calls, and be able to hang around a great group of people. This is all sponsored thru the Boy Scouts of America.

Our Annual Open House will be on October 1st this year. This will coincide with the National Fire Prevention Week in October. More details will be available as we get closer to the date.

I would like, in ending, to thank everyone that attended or donated to our Annual Firefighters' Ball. It again was a great success and we are using the money to buy new equipment and gear to keep the department in compliance with state and federal regulations.
